The Self-Regulatory Initiative (SRI) establishes a voluntary agreement for improved energy and resource efficiency, and end of life treatment and recycling of games consoles

The SRI details the scope, definitions and commitments, and other administration elements



#### **SIGNATORIES**



The SRI covers games consoles placed on the EU market by the Signatories

The Signatories are the three manufacturers producing all the games console models that fall into the scope of the SRI

Microsoft Corporation

Nintendo Co., Ltd.

Sony Interactive Entertainment Inc.

They represent 100% of the EU market - accounting for around 10 million units sold in 2017

Five games consoles fall within the scope of the SRI

#### **MARKET COVERAGE**



The Signatories, in aggregate, must account for more than 80% of the unit sales of Games Consoles in the EU

Each Signatory must ensure that at least 90% of the games consoles it places on the market and/or put into service meet the requirements of the SRI

#### **NON-ENERGY COMMITMENTS**



#### **Resource efficiency**

making available a refurbishment or out-ofwarranty repair service

supported by technical documentation

supported by the availability of spare parts

design should facilitate non-destructive disassembly

marking of plastic parts according to material composition for efficient recycling

#### Information in the instructions for use


Information for consumers is to be provided within console operating instructions - with the console itself, onscreen or hardcopy, or online:

energy consumption data

energy-saving advice (e.g. auto-power down)

signposts to end-of-life, refurbishment and out-ofwarranty service information 05

DATA COLLECTION AND PROCESSING



#### PRODUCT COMPLIANCE REPORT TEMPLATE

- Template from the SRI was transposed into a spreadsheet for completion and subsequent publication
- ❖ The spreadsheet was the same for this reporting period as the previous year
- The same spreadsheet was used for both High and Ultra High definition consoles
- Signatories completed one document containing a page for each console as appropriate
- ❖ For some consoles separate pages were necessary to record updated versions of the same model

#### INDEPENDENT INSPECTOR REVIEW

The Independent Inspector reviewed the Product Compliance Reports (PCRs) against the commitments and requirements of the SRI.

#### This included:

- checking that the declared power caps and APD values met the requirements
- reviewing the sales data against the third party source
- assessing if online links provided direct access to appropriate data

### **INDEPENDENT INSPECTOR OBSERVATIONS**

Measured power consumption data reported in the top part of the PCR did not always
match that given in the 'Information in the Instructions' section
This was not raised in the Individual
Compliance Reports

There were sometimes notable differences between reported sales by the Signatory and those recorded on the public market data website

Revised PCRs with updated sales data were provided

Slarity was sometimes required regarding a model appearing in the public sales data but not reported on

Manufacturers confirmed that for the two models concerned, none were placed on the market in 2017

Vinks to consumer information provided in the PCR did not always followough to pages with relevant or complete information required by the Signatories provided explanations and revised consumer information as appropriate

The issues raised do not constitute any non-compliance with the SRI; the criterion that the Signatory is assessed against for compliance is that a complete PCR is submitted to the Independent Inspector

## COMPLIANCE WITH THE SRI CONSIDERED BY THE INDEPENDENT INSPECTOR



#### Signatories must achieve the following:

- > Demonstrate that the SRI covers 80% of all the games consoles sold in the EU for the preceding reporting period
- Ensure that Product Compliance reports for all games consoles are submitted to the Independent Inspector on time

- > Ensure that the Product Compliance Reports for all games consoles are complete
- Ensure that no more than 10% of products within the scope of the SRI, from that individual Signatory, fail to comply with the requirements in the SRI

## **COMPLIANCE SUMMARY**

Ensure that the <b>Product Compliance Reports</b> for all games consoles are <b>complete</b>	Reports for all games consoles received and completed
Ensure that <b>no more that 10%</b> of products, within the scope of the SRI, from an individual Signatory <b>fail to comply</b> with the requirements in the SRI	All games consoles within scope comply

**RECOMMENDATIONS** 

#### RECOMMENDATIONS BY INDEPENDENT INSPECTOR



As more experience is gained by the Signatories and the Independent Inspector in relation to the SRI, reporting is becoming more streamlined and efficient. Fewer recommendations are suggested.

#### **Data collection and Processing**

- Cessation of production it would be useful if the Signatories could formally communicate when a games console ceases to be placed on the market, in order to confirm that such a model will not be reported on in a particular year
- Sales data it may be useful to have a screen shot of the data source table provided by the Signatory

#### Note:

The reporting process for future reporting periods will be subject to the revised SRI (version 2.5) and as such will be different and sales data reporting may not be routinely necessary.
